Invitation on behalf of IDNIYRA Europe

We are pleased to invite DN sailors in Europe and North America who are members of IDNIYRA to participate in the DN European Championships and European Trophy races from March 11 – March 17 2007.

Entry and Fees

North American IDNIYRA members:

Mail the enclosed form along with a valid certificate of personal liability insurance for a minimum of 500 000 € to the National secretary of Sweden .Entry forms with a postmark after Jan. 17 2007 will be counted as late entry with double fee.

Pay entry fee 100 € for Europeans and European Trophy at check in. Entry fees are not refundable.

European IDNIYRA members:

Send the completed entry form together with the fee for Europeans /European Trophy 100 € and the annual fee for membership in IDNIYRA 30 € to your National secretary.

Make sure you hold an insurance in accordance with the present IDNIYRA Europe requirement for 500 000 € cover.

Your national secretary will register the team by completing and mailing entry list and entry forms to the National secretary of Sweden . He will also arrange transfer of entry and IDNIYRA fees to the bank account of IDNIYRA Europe.

Entry lists and fees postmarked after Jan 17 2007 will be counted as “late entry” with double fees.

European participants not holding an insurance in accordance with the IDNIYRA Europe requirements will not be accepted.

Entry fees and IDNIYRA Europe annual fee are not refundable (except for not accepted entries).

Anti Doping Policy

The participants in the races can be subject to random dope tests according to World Anti-Doping Agency (WADA). If you are using medicine or drugs for medical reasons which are on the prohibited list

you should obtain a Therapeutic Use Exemption (TUE) certificate before the competition.
